DESCRIPTION

The TOGAF 7 PROFESSIONAL SERVICES Product Standard defines the core requirements for knowledge and awareness of The Open Group Architecture Framework (TOGAF), Version 7¹ on the part of IT Architecture practitioners who intend to use it in IT Architecture work.

Secondly, it defines the nature of professional services that may be offered in association with TOGAF Version 7. In so doing, it references a Code of Practice² to which service providers must adhere. Detailed conformance requirements are listed below.

Note: This certification is intended:

- To enable existing IT Architecture service providers to demonstrate that they have personnel with the required knowledge and awareness of TOGAF Version 7 to be able to use it effectively in IT Architecture work
- To ensure that professional services offered in support of TOGAF are delivered by architects who have completed the necessary training and have up-to-date knowledge about TOGAF

This certification is not intended to denote proficiency in IT Architecture practice per se.
